TAXES MAY ALSO BE PAID AT THE CITY TREASURER'S OFFICE LOCATED AT 300 NORTH MAIN STREET ROOM 109. REGULAR HOURS ARE FROM 8:30 AM TO 5:00 PM MONDAY THROUGH FRIDAY. THE OFFICE IS CLOSED ON WEEKENDS AND HOLIDAYS.

**OTHER OPTIONS TO PAY FOR OUR CITIZENS' CONVENIENCE:**

- 1) AN AFTER-HOURS DRIVE-UP **DROP BOX** IS LOCATED BEHIND THE MUNICIPAL BUILDING ACROSS FROM THE POLICE DEPARTMENT ENTRANCE.
- 2) TO PAY BY PHONE OR ONLINE **BY CREDIT/DEBIT CARD OR ECHECK** THROUGH PAYMENTUS, PLEASE CALL **(844) 567-2505** OR GO TO THE CITY'S WEBSITE AT [WWW.HOPEWELLVA.GOV](http://WWW.HOPEWELLVA.GOV) AND SELECT THE "ONLINE PAYMENT" BUTTON. A SERVICE CHARGE IMPOSED BY OUR SERVICE PROVIDER WILL APPLY. YOU WILL BE REQUIRED TO ENTER THE **PARCEL NO. (UP TO 7 DIGITS)** LOCATED ON THE FRONT OF YOUR BILL. IF PAYING BY PHONE OR ONLINE, PLEASE PAY AT LEAST TWO DAYS BEFORE THE DUE DATE TO ENSURE TIMELY RECEIPT OF PAYMENT.
