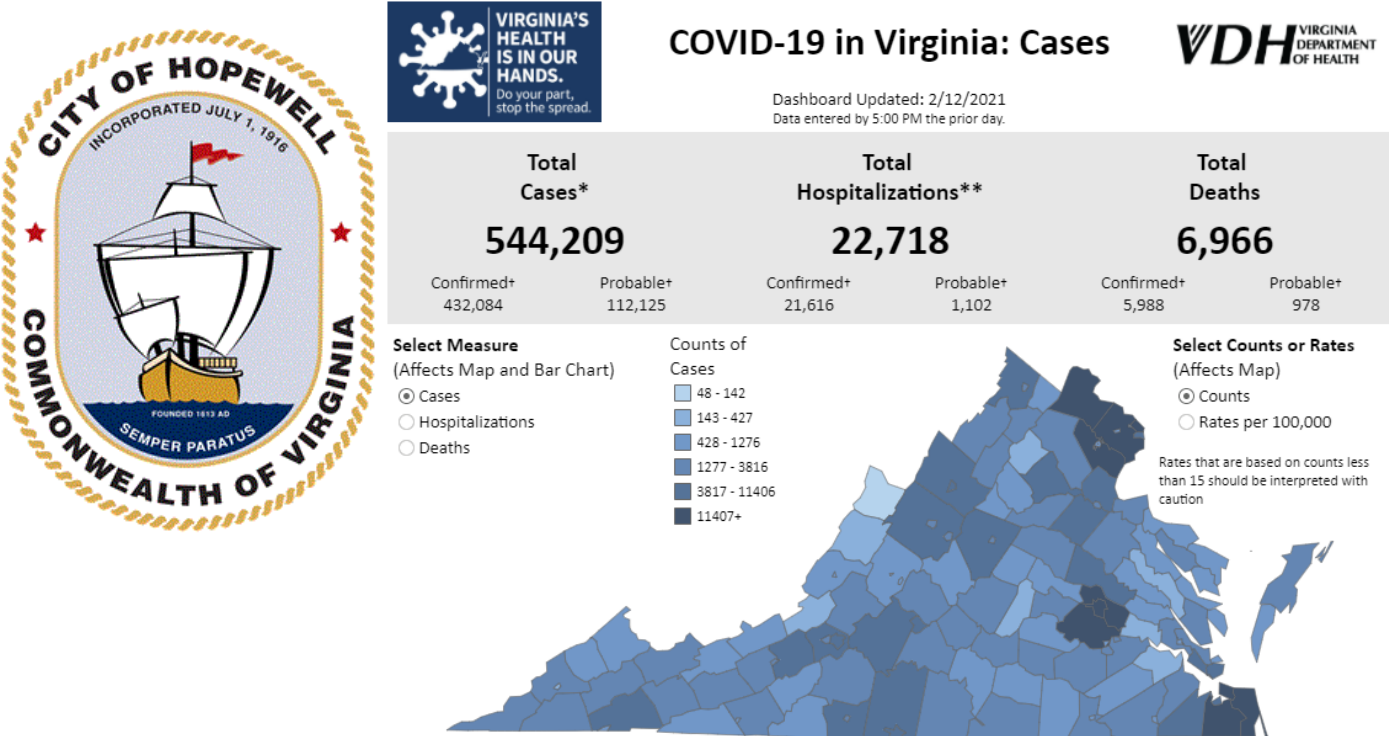

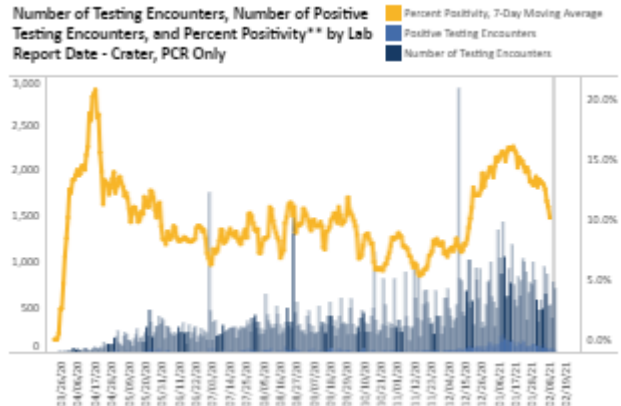
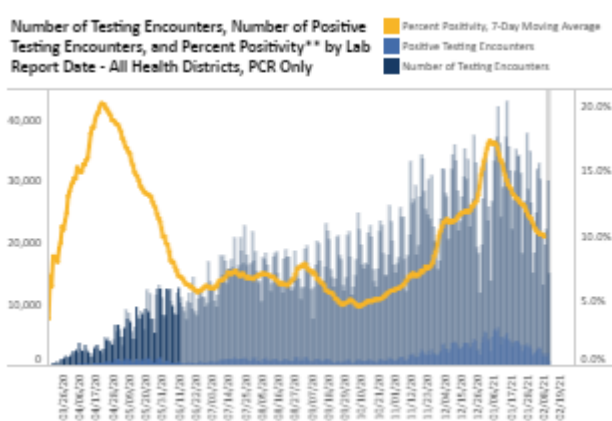

- Testing results by percent positive per VDH at time of report:**

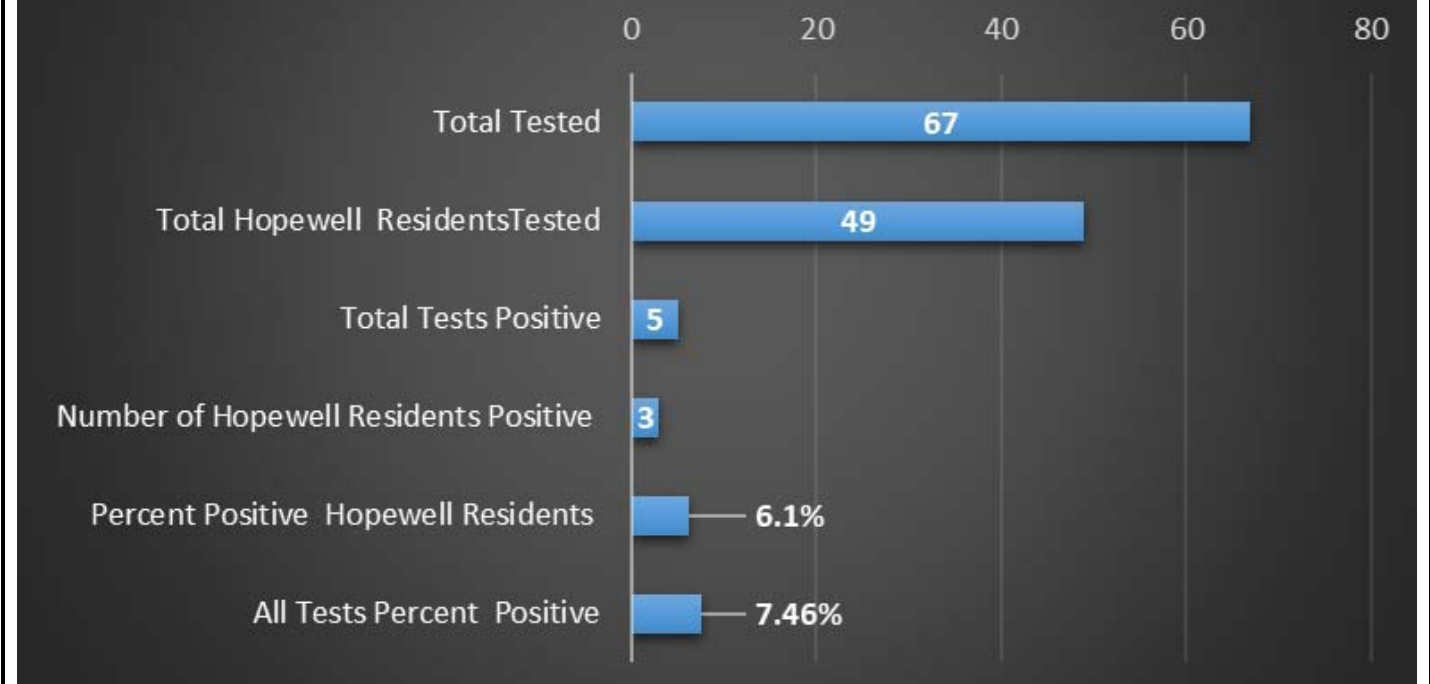

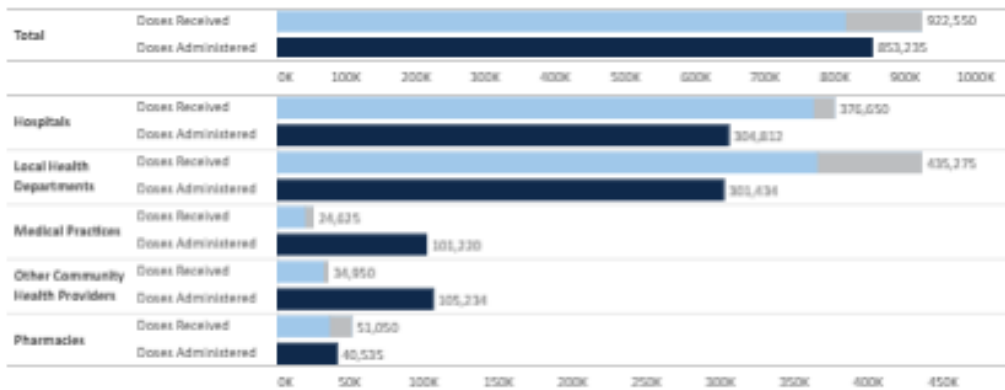
#### Federal Long-Term Care Facility (LTCF) Program Doses Administered and Received



#### Vaccine Received and Administered through Virginia's State COVID-19 Vaccination Program (Does not include Federal LTCF Program)

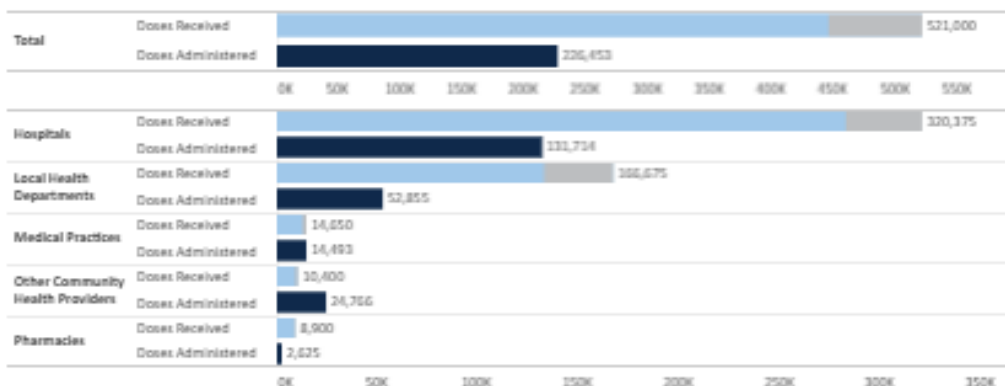
#### COVID-19 Vaccine Received and Administered by Facility Type and Dose\*

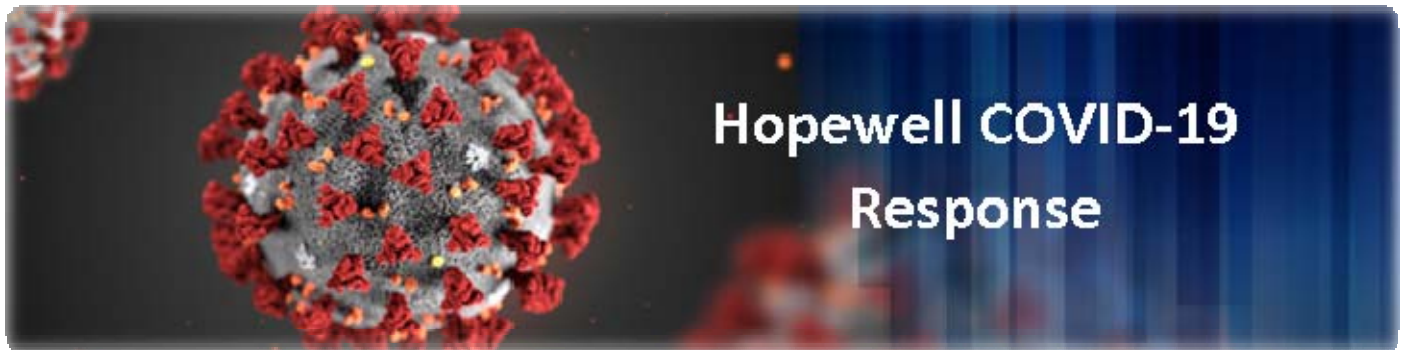

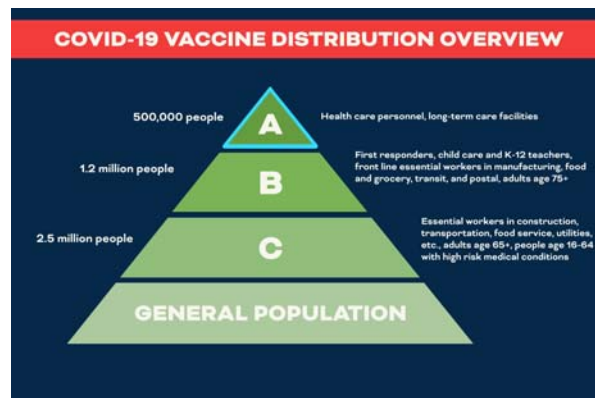

- **EOC prepared for activation and staffing identified. 2/12/2021**
- **Storm preparations continued today across all departments. 2/12/21**
- Vaccination event Saturday canceled due to weather. 2/11/21
- Hopewell Vaccination Call Center went live today at 9:30. 2/10/21
- Planning for response operations to a possible Ice Storm this weekend while continuing vaccination planning simultaneously. 2/10/21
- Due to the Weather forecast and lack of registrants, the testing scheduled for Friday has been canceled. 2/10/21
- Another vaccination clinic for Hopewell / Prince George Schools will be conducted this Saturday from 2:00-5:00 PM at the old Gordman's building in Cavalier Square. 2/9/21
- Hopewell's vaccination call center is going live tomorrow morning at 9:30. The City will begin taking calls from the public and putting people qualified as 1b, on a waiting list for COVID-19 vaccination. 2/9/21
- Training conducted for call center personnel via ZOOM. 2/9/21

They key take-aways are as follows: <ul style="list-style-type: none"> <li>○ A new vaccine dashboard (see above) was launched today, enabling more transparency about where the state is in the vaccination process.</li> <li>○ The state is currently averaging 26,000 vaccinations a day.</li> <li>○ The next goal is 50,000 doses a day, but is subject to supply, which is dependent completely on the Federal government, who has indicated that they can do some limited ramp up of supply to states immediately</li> <li>○ All skilled nursing homes should have vaccinations complete by February 8<sup>th</sup> through the federal contract with CVS and Walgreens. The other assisted living facilities should be done by the end of February.</li> <li>○ The governor announced new guidance on vaccine allocation within the 1b vaccination category. He has directed health departments to provide 50% of their allocation for 1b to go to essential workers, and the other 50% to go to those 65 and older, and those with pre-existing conditions.</li> <li>○ He announced that he will be extending his current COVID-19 executive order restrictions through the end of February.</li> <li>○ The temporary COVID standards developed for the workplace have been made permanent as of today.</li> </ul> </li> <li>• Participated in Regional Conference Call with Crater Health today to discuss vaccination planning going forward. - Governor Northam held a press conference today. No significant changes were announced to the testing, vaccination, or mitigation strategies. 1/14/21
- Access to VAMS was finally gained by Emergency Management. School nurses were uploaded into VAMS along with the other first responders for receiving vaccine. 1/12/20
- Verification of City Staff that falls into category 1b for vaccination was begun today in preparation for the green light to get them uploaded into the system. 1/12/20
- Fire and police are in the process of receiving Vaccinations. 1/8/21
- Covid-19 testing took place today at Cavalier Square. 01/07/2021
  - 97 Tested

- Governor's Office releases Vaccine Distribution model:
  - Group B includes frontline essential workers in specific industries, K-12 teachers and staff, childcare providers, adults age 75 and older, and people living in correctional facilities, homeless shelters, and migrant labor camps.
  - Group C includes other essential workers, adults age 65 and older, and people age 16-64 with certain medical conditions or disabilities that increase their risk of severe illness from COVID-19.



- Governors Press Conference on January 6, 2021- he discussed the goal is to provide vaccinations to the citizens of the Commonwealth based CDC guidelines. Priority groups have been established, with long-term care residents and health care workers as top priority. The goal is to have the general public completed with vaccinations by this summer.
- The Central RHCC activated today, and in Concert with VCU medical center, started performing patient distribution of EMS transports in the ODEMSA EMS region. This was due to the fact that a number of hospitals had gone on diversion. This only lasted about 5 hours before going back to normal status. 1/5/21

These results amount to a 22.58% positivity rate for Hopewell residents, and a 19.64% positivity rate overall. 8/25/20</li> <li>• Community COVID-19 testing was conducted last night and approximately 55 people were tested. 8/21/20</li> <li>• Crater Health is hiring 5 contract employees to assist with testing. This will allow for an additional testing team, and should allow for community testing to occur once every two weeks, versus the once a month now. 8/21/20</li> <li>• Hopewell’s next testing Site has been finalized! 8/14/20</li> <li>• Met with Crater Health and City staff today at the location of the next testing site to be conducted on the 20<sup>th</sup> of August to finalize planning efforts. Crater will be producing a site map to share with the group before the final announcement is officially sent out. 8/10/20</li> <li>• On the Crater Health District call today, the Health department announced that they would be hiring a testing team to augment the testing they are already conducting across the district. This will hopefully get more frequent testing in each of the localities. 8/6/20</li> <li>• On the Crater Health District call today, the following items were reported about the ongoing response at Crater Health district: <ul style="list-style-type: none"> <li>○ Contact tracing is ongoing, and is staffed 7 days a week to ensure continuity.</li> <li>○ Additional contact tracers are being brought on board, and several will be assigned special categories, including schools, businesses, etc.</li> <li>○ Community testing events are ongoing through the rotation established. Percent positivity has been up recently due to targeted events. Percent positivity has ranged from 11-21%</li> <li>○ Crater is looking for assistance with vaccinating school children from area Paramedics. A plan is being developed for that now. 7/30/20</li> </ul> </li> <li>• VDH reported on the Crater Health Call today that there are between 5 and 7 vaccines which may be approved as early as December/January. They are manufacturing them as they are conducting clinical trials so that if approved they can be deployed immediately. 7/23/20</li> <li>• VDH-Crater is focusing planning assets on identifying what will be needed (Facilities, Supplies, PPE, Equipment and Personnel) to deliver seasonal flu shots in a Point of Dispensing (POD) situation occurring in accordance with COVID-19 restrictions and guidelines. The 2020 POD exercise will take place in Petersburg.</li> <li>• VDH-Crater participated in a mobile testing event in Carson (Prince George County) on 7/16/2020</li> <li>• Participated in Crater Health regional call today. The discussion focused around mobile testing that is on-going.
