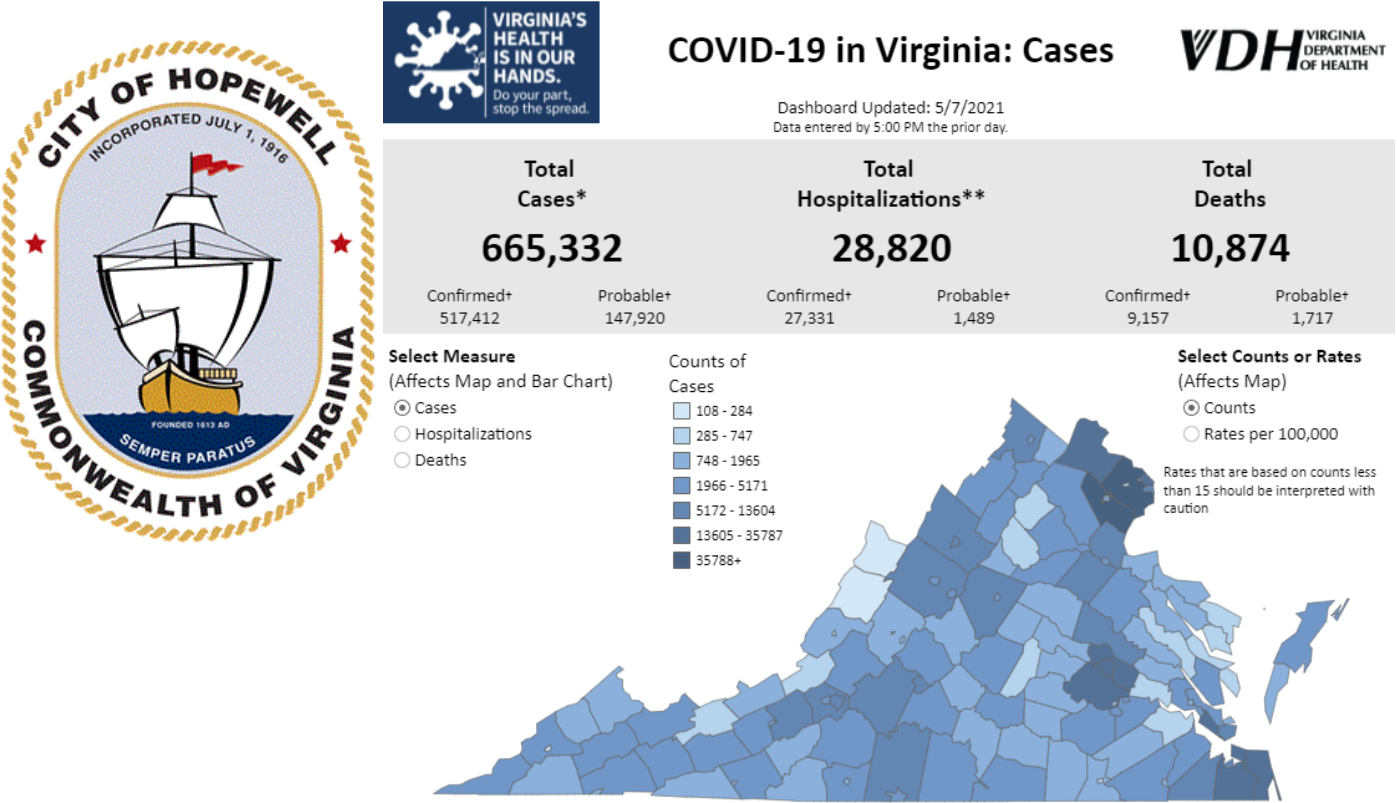

• **Statewide cases per VDH at time of report:**



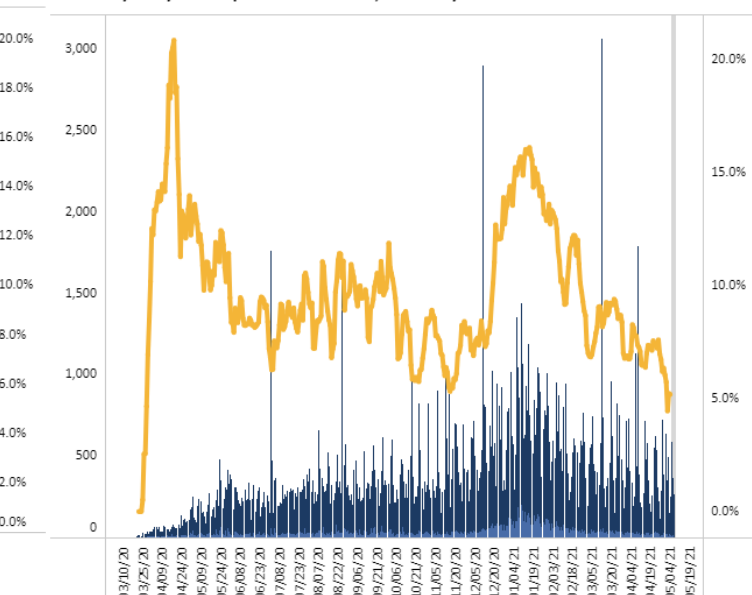
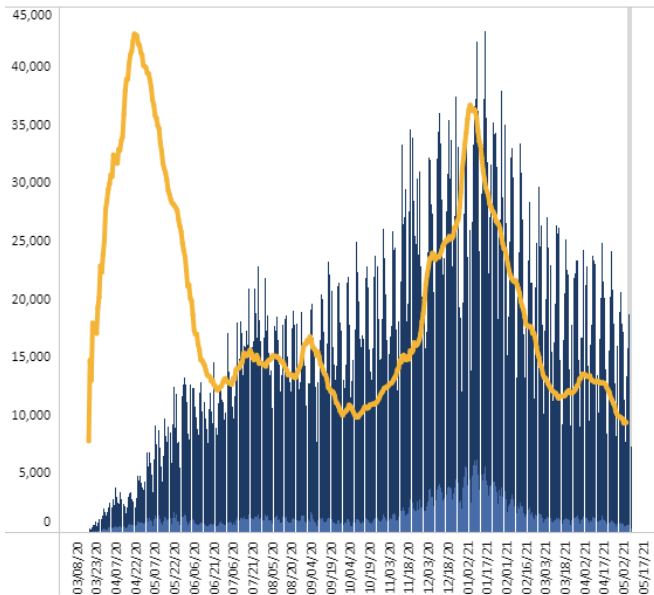

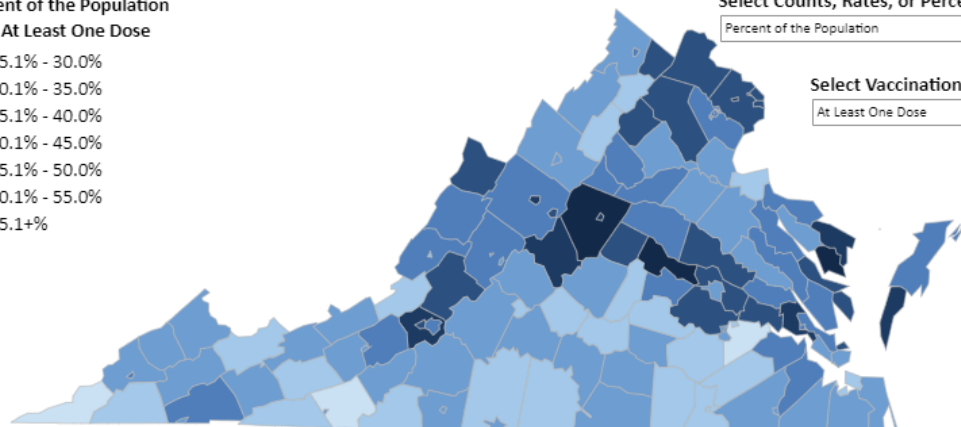

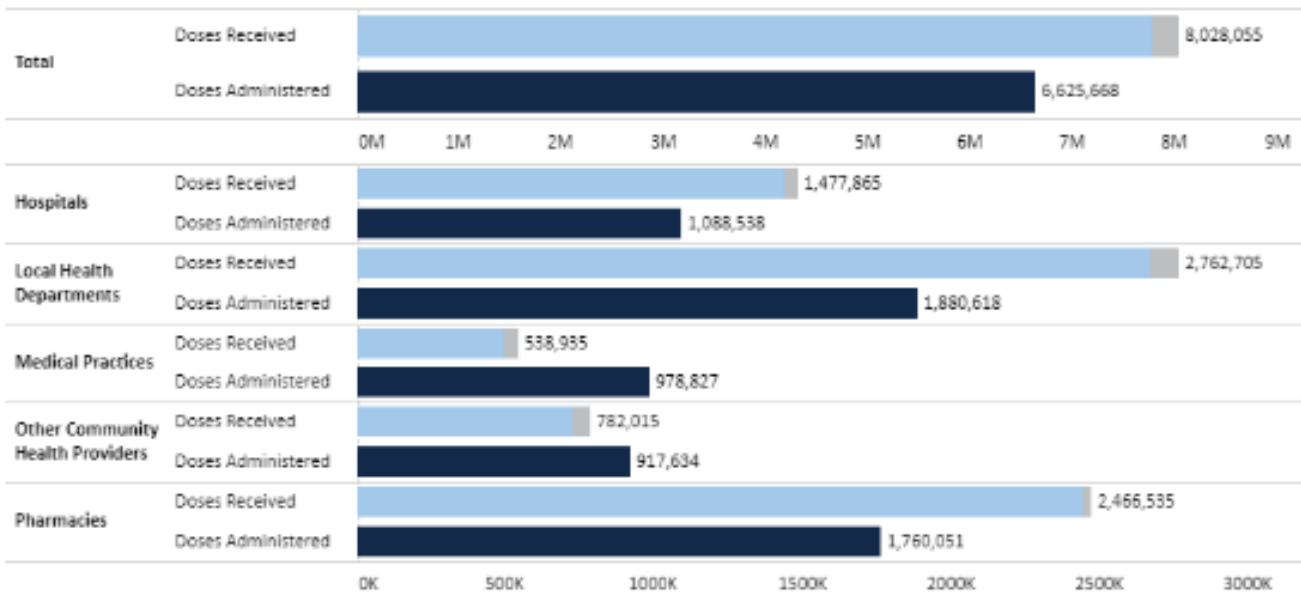

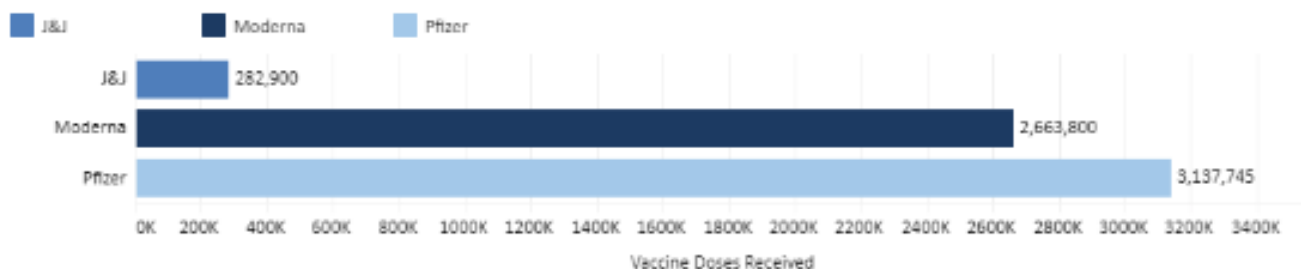

### COVID-19 Vaccine Received and Administered by Facility Type\*

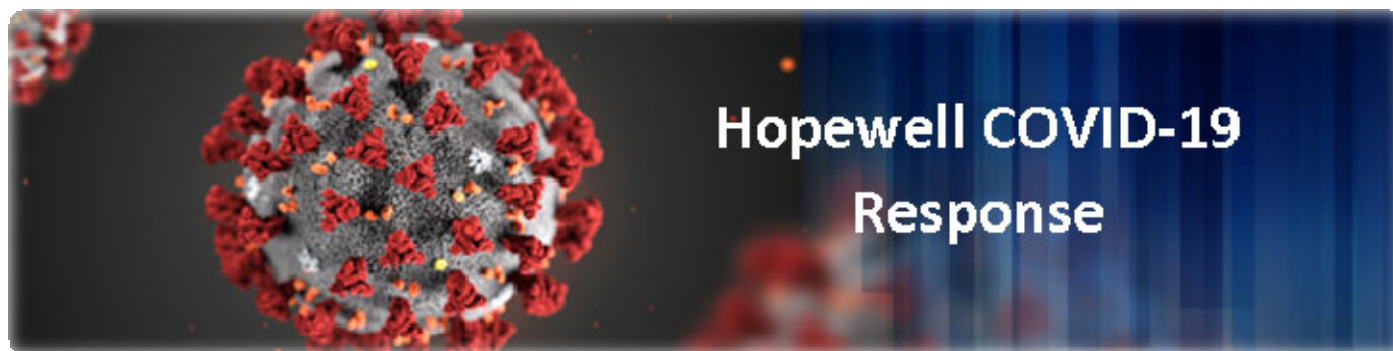

### Critical Takeaways on Response in Central Virginia:

- **The City will host a Vaccination event on Friday May 14<sup>th</sup> from 9:00-12:00 noon at 315 Cavalier Square (Gordman's).**
- **Hopewell hosted two mobile clinics in the City on Tuesday April 4<sup>th</sup>. from 10:00-12:00 pm at Piper Square Community Center, and from 2:00-4:00 pm at Thomas Rolfe Community Center. The Educate Vaccinate team did outreach in the surrounding area for both events. 7 Vaccines were administered as a result of these events.**
- **The City hosted a vaccination clinic today from 09:00-12:00pm at 315 Cavalier Square (Gordman's). 117 Vaccine doses were administered as part of this event.**
- Hopewell hosted a mobile vaccination clinic at the Davisville/Bland Court Community Center today from 2:00-4:00 PM doses of vaccine were administered.
- Hopewell hosted a mobile vaccination clinic at 100 Kippax (Kippax Place) on Wednesday April 28<sup>th</sup> from 1:00-4:00 PM. The Educate Vaccinate team conducted door-to-door outreach in the surrounding area before and during the event. 50 Doses of vaccine were administered. 4/30/21
- Next week Hopewell will host two mobile clinics in the City on Tuesday April 4<sup>th</sup>. The first will be from 10:00-12:00 pm at Piper Square Community Center, and the second from 2:00-4:00 pm at Thomas Rolfe Community Center. The Educate Vaccinate team will be used to do outreach in the surrounding area for both events.
- The City will also host a vaccination clinic next week on Friday April 7<sup>th</sup> from 09:00-12:00pm at 315 Cavalier Square (Gordman's).
- On Thursday April 29<sup>th</sup> Governor Northam announced several changes to his executive orders in relation to the COVID-19 Pandemic. These included the following:
  - Executive Order Seventy-Two was amended to adopt [new guidance](#) from the Centers for Disease Control and Prevention (CDC) on mask use in outdoor settings. The CDC guidelines state that fully vaccinated individuals do not have to wear masks outdoors when alone or in small gatherings. Mask use is still required indoors and outdoors at large crowded events like concerts, sporting events, and graduation ceremonies. People are considered fully vaccinated two weeks after receiving the last required dose of vaccine.
  - Executive Order Seventy-Two was amended to allow up to 1,000 spectators for outdoor recreational sports, effective immediately. This change advances by two weeks a change that was scheduled to go into effect on May 15 and will allow additional spectators to participate in final games of the current high school sports season and the summer sports season.
- On Saturday 4/24 Hopewell will host a 500 shot Moderna vaccination clinic at 315 Cavalier Square (Gordman's). This will be a Hopewell Prince George Clinic. 4/23/21

<ul style="list-style-type: none"> <li>• The “Educate Vaccinate” group under contract with VDH went door to door encouraging people to go and register onsite at the vaccination clinic today at Gordman’s. Their outreach efforts included The Summit, Twin Rivers, and the neighborhoods directly adjacent to Cavalier Square. 4/23/21</li> <li>• Next week Crater Health District has tentatively planned mobile clinics at 100 Kippax on Wednesday from 1:00-4:00 pm , and Davisville/Bland Court on Friday from 1:00-4:00 pm. Personnel from Educate Vaccinate will be helping to market these events in their respective neighborhoods. 4/23/21.</li> <li>• Hopewell hosted a Pfizer vaccination clinic today. 462 doses of Pfizer were administered today. 4/23/21</li> <li>• On April 22<sup>nd</sup>, Governor Northam announced changes to COVID-19 restrictions starting May 15th these include the following: <ul style="list-style-type: none"> <li>○ <u>Social gatherings</u>: The maximum number of individuals permitted in a social gathering will increase to 100 people for indoor settings and 250 people for outdoor settings. Social gatherings are currently limited to 50 people indoors and 100 people outdoors.</li> <li>○ <u>Entertainment venues</u>: Indoor entertainment and public amusement venues will be able to operate at 50 percent capacity or 1,000 people, up from 30 percent capacity or 500 people. Outdoor venues will be able to operate at 50 percent capacity—up from 30 percent—with no specific cap on the number of attendees.</li> <li>○ <u>Recreational sporting events</u>: The number of spectators allowed at indoor recreational sporting events will increase from 100 to 250 spectators or 50 percent capacity, whichever is less. Outdoor recreational sporting events will increase from 500 to 1,000 people or 50 percent capacity, whichever is less.</li> <li>○ <u>Alcohol sales</u>: Restaurants may return to selling alcohol after midnight, and dining room closures will no longer be required between midnight and 5:00 a.m.</li> </ul> </li> <li>• On Friday 4/23 Hopewell will host a 1,000 shot Pfizer vaccination clinic at 315 Cavalier Square (Gordman’s). This will be a combination first and second shot clinic. 4/16/21</li> <li>• Hopewell hosted a Pfizer vaccination clinic on Friday 4/26 at 315 Cavalier Square (Gordman’s). This was a combination first and second shot clinic. 580 doses of vaccine were administered. 4/16/21</li> <li>• The CDC and the FDA put a temporary halt on Johnson and Johnson vaccine while several rare case of blood clot development after vaccine administration are investigated. 4/16/21</li> <li>• Governor Northam announced that the entire State is going to Phase 2 on April 18<sup>th</sup>. The highlights of those changes are as follows: <ul style="list-style-type: none"> <li>○ <b>Current Modified Stay at Home order will expire on February 28<sup>th</sup></b></li> <li>○ <b>Social gatherings:</b> The maximum number of individuals permitted in a social gathering will increase from 10 to 25 people for outdoor settings, while remaining at 10 persons for indoor settings.</li> <li>○ <b>Entertainment venues:</b> Outdoor entertainment and public amusement venues will be able to operate with up to 1,000 individuals or at 30 percent capacity, whichever is lower. If current trends continue, these venues may be able to operate at 30 percent capacity with no cap on the number of people permitted to attend starting in April. Indoor entertainment and public amusement venues must continue to operate at 30 percent capacity with a cap of 250 people. All entertainment venues were previously limited to a maximum of 250 individuals.</li> <li>○ <b>Dining establishments:</b> The on-site sale, consumption, and possession of alcohol will be permitted until midnight, extended from 10:00 p.m. All restaurants, dining establishments, food courts, breweries, microbreweries, distilleries, wineries, and tasting rooms still must be closed between midnight and 5:00 a.m.</li> <li>○ <b>Overnight summer camps:</b> As of May 1, overnight summer camps will be able to open with strict mitigation measures in place. Registration can begin now.</li> </ul> </li> <li>• EOC prepared for activation and staffing identified. 2/17/2021</li> <li>• Storm preparations continued today across all departments. 2/17/21</li> </ul>			

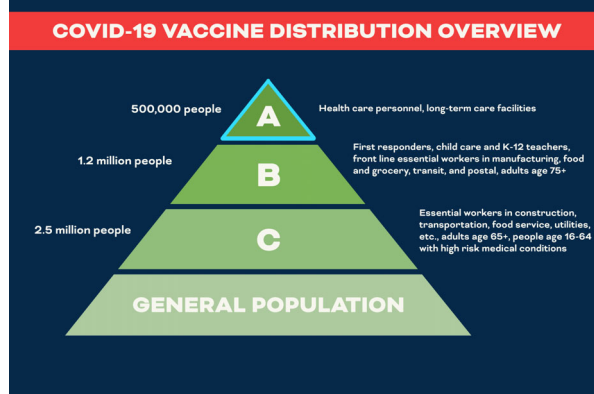

<ul style="list-style-type: none"> <li>• COVID-19 Vaccine –Virginia Statewide Pre-Registration System on line as of 2/16/2021</li> <li>• COVID- 19 testing event cancelled for February 18, 2021.</li> <li>• EOC activated and managed winter storm and water outage from 2/14/2021- 2/16/2021</li> <li>• EOC prepared for activation and staffing identified. 2/12/2021</li> <li>• Storm preparations continued today across all departments. 2/1/21</li> <li>• Vaccination event Saturday canceled due to weather. 2/11/21</li> <li>• Hopewell Vaccination Call Center went live today at 9:30. 2/10/21</li> <li>• Planning for response operations to a possible Ice Storm this weekend while continuing vaccination planning simultaneously. 2/10/21</li> <li>• Due to the Weather forecast and lack of registrants, the testing scheduled for Friday 2/12/2021 has been canceled. 2/10/21</li> <li>• Another vaccination clinic for Hopewell / Prince George Schools will be conducted this Saturday from 2:00-5:00 PM at the old Gordman’s building in Cavalier Square. 2/9/21</li> <li>• Hopewell’s vaccination call center is going live tomorrow morning at 9:30. The City will begin taking calls from the public and putting people qualified as 1b, on a waiting list for COVID-19 vaccination. 2/9/21</li> <li>• Training conducted for call center personnel via ZOOM. 2/9/21</li> <li>• The next scheduled testing event will be Friday, February 12<sup>th</sup> from 10:00-12:00. This is a Crater Health testing event. Pre-registration is required by calling 804-862-8989. 2/9/21</li> <li>• Participated in a statewide vaccination support call hosted by VDEM. They laid out a process for communicating vaccination response information amongst local administrators and elected officials, as well as some ongoing planning efforts for some large vaccination sites across the state. 2/9/21</li> <li>• Closed vaccination clinic for Hopewell / Prince George Schools completed on Saturday 2/6/2021 approximately 400 people vaccinated.</li> <li>• Work was completed on prepping the building, for the vaccination clinic, this Saturday at the old Gordman’s building in Cavalier Square. 2/4/21</li> <li>• Work continued on acquiring the human resources for the vaccination site Saturday. 2/4/21</li> <li>• Training was conducted for call center takers. 2/4/21</li> <li>• Work continued on prepping the building, and acquiring resources for the vaccination clinic, this Saturday at the old Gordman’s building in Cavalier Square. 2/3/21</li> <li>• Work continued on call center preparations as well. 2/3/21</li> <li>• Old Gordman’s site in Cavalier Square has been approved by Cavalier Square Management, as our vaccination site in the City. We are currently working through the process of getting it prepared for use, including cleaning, utilities etc. 2/2/21</li> <li>• First Vaccination event in the City will be conducted this Saturday. It will closed to the public by invitation only. <ul style="list-style-type: none"> <li>• COVID testing conducted on Friday 1/29 at Cavalier Square – 29 people tested.</li> <li>• The Governor hosted a press briefing today. They key take-aways are as follows: <ul style="list-style-type: none"> <li>○ A new vaccine dashboard (see above) was launched today, enabling more transparency about where the state is in the vaccination process.</li> <li>○ The state is currently averaging 26,000 vaccinations a day.</li> <li>○ The next goal is 50,000 doses a day, but is subject to supply, which is dependent completely on the Federal government, who has indicated that they can do some limited ramp up of supply to states immediately</li> <li>○ All skilled nursing homes should have vaccinations complete by February 8<sup>th</sup> through the federal contract with CVS and Walgreens. The other assisted living facilities should be done by the end of February.</li> <li>○ The governor announced new guidance on vaccine allocation within the 1b vaccination category. He has directed health departments to provide 50% of their allocation for 1b to go to essential workers, and the other 50% to go to those 65 and older, and those with pre-existing conditions.</li> <li>○ He announced that he will be extending his current COVID-19 executive order restrictions through the end of February.</li> <li>○ The temporary COVID standards developed for the workplace have been made permanent as of today.</li> </ul> </li> <li>• Participated in Regional Conference Call with Crater Health today to discuss vaccination planning going forward. Key take-aways are below 1/25/21: <ul style="list-style-type: none"> <li>○ Currently Crater Health is using all of the vaccine they are receiving from the state working on groups 1A and starting into some 1B in their current closed POD method.</li> <li>○ They are currently moving from the VAMS system for registration to Prep-Mod software.
